Prepayment Incentive Program

PROGRAM OVERVIEW

Customers that deposit a prepayment amount of at least \$10,000 (via cash, check, ACH, or wire transfer only) with Reichman Sales & Service during the period between October 1, 2022 and January 31, 2023 shall be eligible to receive an incentive (appearing as a credit to account) of up to .4167%/month (equating to 5% per annum) on the unused portion of that prepayment amount.

The incentive shall begin accruing on the date the eligible prepayment amount is received and shall stop accruing on the sooner of July 31, 2023, the date the prepayment amount has been fully used, and the date Reichman Sales & Service has received a written refund request from customer for any unused portion of the prepayment amount. Incentives for any partial month shall be pro-rated.

The incentive will be calculated at month-end based on the unused portion of the eligible prepayment amount reduced by any accounts receivable outstanding at the end of that month. The incentive will appear as a credit to customer's account in the monthly statement provided during the month after the calculation is made.

Eligible prepayment amounts may be used to purchase any products or services from any Reichman Sales & Service location from October 1, 2022 onward.

Accrued and unused incentive amounts may be used to purchase any products or services from any Reichman Sales & Service location from October 1, 2022 until August 31, 2025 at which point any unused incentive amounts will be forfeited. The prepayment amount and the incentive must be used prior to all other credits.

ADDITIONAL PROGRAM DETAILS

Participation in this program is subject to the customer signing Reichman Sales & Service's Prepayment Incentive Agreement.

The incentive is not compounded. The incentive is calculated using the unused portion of the original prepayment amount at month's end.

The incentive must be used to purchase Reichman Sales & Service product or services and is not refundable. The unused portion of the prepayment amount is refundable in accordance with the Prepayment Incentive Agreement.
