## PRODUCT INFORMATION

HIGH LOAD<sup>®</sup> MSO is a modified vegetable oil/surfactant blend that aids in penetration and spreading of the spray mixture through a plant's waxy cuticle.

HIGH LOAD MSO helps increase the effectiveness of many post-emergent herbicides. It is designed to be used at a reduced rate when compared to other methylated seed oil products. HIGH LOAD MSO allows for quicker absorption and uptake of the herbicide into the plant, including tough-to-control weed species.

HIGH LOAD MSO may be used when a pesticide label requires the addition of a methylated seed oil or a crop oil concentrate.

## DIRECTIONS FOR USE

**GENERAL WEED CONTROL:** Use 4-32 fluid ounces of HIGH LOAD MSO per acre. Rates may vary due to the conditions in which the application is made. During periods of drought, extreme stress and/or high weed populations, the high end of the rate may be necessary

**DO NOT ADD THIS PRODUCT AT A RATE WHICH EXCEEDS 5% OF THE FINISHED SPRAY VOLUME.**

Always follow the adjuvant use recommendations as shown on the pesticide label. The pesticide manufacturer's label regarding specific usages and restrictions takes precedence over the directions for use shown on this label.
